Information, Reports, and Recommendations

Ms. Carla Freemyer presented a demonstration of a paperless board meeting. Asheboro City Schools is pursuing improving the production process behind board meeting preparation, embracing technology and saving paper. The Board unanimously approved moving forward with paperless board meetings beginning March 2008. Mr. Mike Mize shared information on electric and natural gas usage. Both electric and gas usages are up due to new projects such as the Asheboro High School Zoo School and the Teachey addition.

Ms. Marty Williams informed the Board that the State Board of Education approved Asheboro City Schools as a recipient of an IMPACT Grant. Asheboro City Schools will receive over \$1.2 million in technology funding for equipment, software, training, and evaluation for North Asheboro Middle, South Asheboro Middle and Asheboro High School.

Action Items

The proposed 2009-2010 School Calendar was unanimously approved by the Board. School will begin for students on August 25, 2009 and end June 9, 2010.

The Board unanimously approved the 2008 Legislative Platform Proposal. Top priorities are maintaining local control on the number of LEAs per county, reinstating the five teacher workdays which were eliminated in the calendar law changes of 2004 since those days are essential for professional development of school personnel, and providing sufficient funds to guarantee that all funding formulas are fully funded.

The Board unanimously approved Budget Amendment CE-03 to appropriate \$90,000.00 from the fund balance for public utilities.

Superintendent's Report/Calendar of Events

Ms. Freemyer shared the Calendar of Events noting several important dates as follows: Evening of Excellence, February 25, 2008; Legislative Breakfast, February 29, 2008; District Expert Project Fair, March 13, 2008; 2008-2009 Kindergarten Information Night, April 8, 2008; and Teacher of the Year Banquet, May 22, 2008.

Ms. Freemyer presented the following *Points of Pride*: Middle School Science Fair winners; School Spelling Bee winners; and Asheboro High School Mock Trial Teams placing 1^{st} and 2^{nd} in regional competition.

Dr. Diane Frost presented an update on the Joint Legislative Study Committee on school funding formulas. The Committee is considering commissioning a major study of North Carolina's approach to school finance.

Mr. Tom Quinn with Sodexho informed the Board of a USDA beef recall. Asheboro City Schools has 64 cases that will be picked up early next week by Food Distribution and destroyed.

Dr. Frost reminded the Board of Master Board Training Module 2 on "Teambuilding" to be held March 6, 5:00 p.m., at the Professional Development Center.
